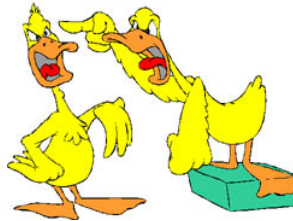

Entertainment activities

- Lawn darts** Your Health Insurance coverage will be in effect only until darkness sets in.
